## **AUTHORS' GUIDELINES**

Submissions should not exceed 12000 words. Accepted manuscripts will be available in print. All submissions will be liable to a non-refundable fee of 20,000 FCFA (35 USD) and should be paid via MoMo to (237) 676102438/699421877.

### **Copyright Disclosures**

Articles published in the *INSTRUCTOR: JCSA* become the property of the Journal. Articles submitted to the *INSTRUCTOR: JCSA* should not be submitted to other periodicals at the same time. They must be an original contribution, the Editor-in-Chief should be informed in case the article was already submitted to another periodical. Authors receive a free copy of the issue in which their article is published.

### **Article Format**

- Manuscripts must be written in English or French on an A4 size paper (21 cm wide and 29.7 cm long) with margins 2 cm all round. Only Microsoft word format will be accepted. Research articles should follow the order: Introduction/Background, Methodology, Results and Discussion, Conclusion, Acknowledgements, Author contributions, Conflict(s) of Interest, and References.
- Font size should be 12 for the body and subheadings, and 16 for the main title with line spacing 1.5, all written in Times New Romans. Paragraphs should start at the margin and the pages and lines should be numbered. All headings should be in **bold**.
- The first page should bear the complete title of the article (justified), full name(s) of the author(s), their affiliation(s), the email address, contact/WhatsApp number of the corresponding author, the abstract of the article ( $\leq 250$  words) and keywords ( $\leq 6$ ).
- The abstract should be concise and written as a block, with no separation or subheadings.
- Apart from the main title, all titles and subtitles should be numbered in sequential order (Arabic numerals: 1, 1.1, 2, 2.1 etc), and left aligned, while the body of the manuscript should be justified.
- Diagrams, tables and other illustrations should be numbered serially; must

be aligned in the centre.

- Titles for tables should be above, and charts below, while sources and legends should be below tables and charts.
  - Photos and colour drawings should all be printed in black and white (this option will be updated over time). Thus, make sure they are clear, visible, and convey the characteristics/message you desire before final submission. These photos or diagrams should be composed and cropped in such a way that they do not scatter during composition/processing.
  - The statement ‘The authors declare that they have no conflict of interest’ should be written in the case where there are no conflicts of interests.
  - All contributors which are not authors, funding bodies or grants should be acknowledged, with the grant numbers and funding bodies written in full.
  - Definitions and theorems must be numbered using Arabic numerals in the order presented in the text.
  - Citations should be done following APA referencing. Footnotes in the form of explanatory notes or copyright information are permitted. Endnotes NOT accepted.
  - A list of references (bibliography) must be included following the APA referencing style.
  - All supplementary material must be submitted in standard file format.
- NB: All these instructions must be scrupulously observed.

**Language (s) of Publication:** The *INSTRUCTOR: JCSA* accepts manuscripts in the English and French languages.

### **Ethical Considerations**

Authors must respect ethical standards for research particularly the validity of the research, non-maleficence, justice, etc. Thus, all articles will be subject to an evaluation to verify that the study followed the guidelines for good practice. Once the paper is accepted, it becomes the property of the Journal and cannot be published in another journal.

### **Executive overview**

*INSTRUCTOR: Journal of Computer Science and Applications* ethics policy was designed based on the guidelines and recommendations of the Committee on Publication Ethics (COPE). It is therefore our responsibility at HTTC to ensure that the quality of the works we publish meets the standards. Our goal as an academic publisher is to maintain the accuracy, integrity, and completeness of the scientific record by ensuring that the honest and most accurate publication is promoted through strict policies. Our team of experienced writers, peer reviewers and advisors have vowed to uphold these guidelines.

**Paternity****What is Fatherhood?**

According to COPE, the term authorship can refer to the creator or initiator of an idea (for example, the author of the theory of relativity) or the person or persons who develop and make the product which disseminates intellectual works or creative (for example, the author of a book or scientific article). Fatherhood confers important privileges, responsibilities and legal rights; in academia, it also forms the basis for rewards and career advancement. Various disciplines have standards, guidelines and rules governing authorship; some of these rules preserve the lineage of ideas or works, the design and production of studies or experiments to validate theory, analysis of results and actual writing of works to disseminate knowledge. Authors are required to follow discipline-specific guidelines when engaging in authorship activities; journal editors and editors are responsible for making authoring guidelines transparent and appropriate for the medium (scholarly books, journal articles, creative writing). At a minimum, authors should ensure that they have done the work as presented and that they have not violated the legal rights of another author (e.g., copyright) in the process.

**Paternity conditions and agreement**

- All named authors contributing to *the INSTRUCTOR: JCSA* sign an authorship consent form as a condition of publication. The statement should ideally include:
  - A statement that this individual, and all other named authors, meet the authorship criteria set out in the journal's authorship policy.
  - A statement that no other person worthy of authorship has been omitted
  - A statement of that person's exact contribution to the article (journals should also consider publishing this information).
  - A statement that a person takes responsibility for the integrity of the paper.

**Guidelines for resolving paternity disputes**

- The author's position in an article should be decided by the authors before submitting the article for review for publication. We will consider publishing the article in the order in which the names of the authors are received.
- Additional authors cannot be added after submission.
- The authors cannot be replaced in the event of illness, insanity or death.

**Conflicts of Interests**

We require authors, editors and reviewers to declare any relevant competing interests of a personal, professional or financial nature at the time of submission (for authors) or acceptance to review a manuscript—for editors and reviewers).

For example, financial or personal relationships with other people or organizations that could influence or inappropriately bias their work, or could be perceived to do so.

It is the authors' responsibility to disclose affiliations with any organization having a financial interest, direct or indirect, in the subject or materials discussed in the manuscript (such as consultants, employment, testimony from paid experts, fees, speakers' offices, honoraria, stock options or property, patents or patent applications or travel grants). All sources of research funding must be explicitly indicated. When in doubt as to what could be considered a potential competing interest, authors should favour full disclosure.

The cases of conflict of interest which must be mentioned are as follows:

- Whether the editor of the journal is a parent or a family member.
- Whether you work with the journal or the editor in any position.
- Whether you received a research grant or financial support from an internal or external source.

### **Ethics and consent**

All of the research articles we publish are held to a high ethical standard. The journal endorses the Publishing Ethics Committee (COPE) Code of Conduct, as well as the COPE International Standards for guidelines for editors and authors. The editorial board of each journal is responsible for shaping the peerreview process.

### **Plagiarism and other Forms of Academic Malpractice**

Academic dishonesty, fraud or academic misconduct is any type of cheating that occurs as part of a formal academic exercise. This can include plagiarism, coercive authorship; gift of article publishing or honorary authorship.

### **Plagiarism**

Plagiarism is the adoption or reproduction of ideas, words or statements from another person without proper mention. It can also include the inability to quote correctly or a poor understanding of citation style languages. A self-citation is a reference to an article by the same author in the same journal or in other journals.

Plagiarism can vary depending on the level of severity. Here are some of the levels at which a work can be plagiarized:

Coercive Translation: This involves translating other people's works into other languages and then personalizing them without recognizing the owner.

How to avoid this:

- Obtain consent before translating other people's work.
  - Give credit to the legitimate owner of the work.
  - Read extensively on best practices for translating published works.
- Substantial and literal copy: Reproduction of a work verbatim, in whole or in part, without authorization and without mention of the original source.



Implication on research results: this may compromise research through replication, therefore no new / significant contribution to existing literature.  
Author involvement: can destroy your reputation as a scholar.

### **Article Withdrawal Guidelines**

We may consider removing a manuscript if:

- It constitutes more than 15% of plagiarized content.
- There is clear evidence that the results are unreliable, either due to a major error such as miscalculation or experimental error, or due to fabricating data or tampering such as manipulation, Images, etc.
- Results have already been published elsewhere without proper attribution to previous sources or disclosure to publisher, permission to republish, or justification (i.e., cases of redundant publication)
- It contains material or data without authorization for use.
- Copyright has been infringed or there is some other serious legal issue (e.g., defamation, confidentiality).
- It reports unethical research
- It was published solely on the basis of a compromised or manipulated peer review process.
- The author(s) have not disclosed a major competing interest which, in the opinion of the publisher, would have improperly affected the interpretations of the work or the recommendations of the editors and peer reviewers.
